

Ronald Reagan Way

The Ronald Reagan Way project is a \$2.3 million new roadway project on a challenging site designed to serve a 400,000 square foot office building, the new FBI Regional Headquarters, and a 400 room hotel in Sycamore Township. BCI began work on this project in 2007 with a Traffic Impact Study and then partnered with URS on the Design Phase. Although the project was led by Sycamore Township, the project stakeholders included the following entities: Sycamore Township, City of Madeira, Hamilton County Engineer Office, Duke Realty, Neyer Properties, Skanska, and the FBI.

As is evident from the photos, the new roadway needed to compliment the existing Towers of Kenwood office towers, while minimizing impacts to the residential area to the South. The use of a Redi-Rock gravity modular retaining wall enabled the excavation limits to be reduced in an effort to save mature trees which provided a buffer for local residents.

Early discussion with Duke Realty afforded them an opportunity to improve their access in and out of their building at the conclusion of the project. The access point for their delivery and service vehicles was modified which also enabled them to relocate refuse locations to a more aesthetically applicable location on their site.

The project was constructed by the Fred A. Nemann Company and was substantially completed in 2011, with the final surface course being applied in the Spring of 2012. Work was able to continue during the winter months of 2010/2011 due to the scale of earthwork and the type of retaining walls which were installed. Winter construction was critical to the overall success of the project because the roadway had to be completed prior to the opening of the FBI Regional Headquarters. Skanska was the Construction Manager for the new building and all of their construction equipment, materials, and labor still needed to access their site during all phases of construction. Close coordination and communication between all parties was important to ensure that construction could continue on both the roadway and the building.

The project was funded through a Township Tax Increment Financing (TIF) program specifically generated from the incremental taxes generated by the proposed development.

The project included an underground detention system for stormwater control, underground utilities, new decorative lighting, water main, and sidewalks on the south side of the road for pedestrian access. The new traffic signal serves the intersection at Hosbrook Road and provides an efficient means of egress for the hotel and office users in the development.

A second phase of this project is in the design phase of work and will continue the roadway improvements on Hosbrook Road up to Montgomery Road. This phase of the project will require coordination with the proposed development at the southwest corner of Hosbrook Road and Montgomery Road. It is also scheduled to include a utility relocation phase for Montgomery Road from I-71 to just east of Hosbrook Road.


Between now and May 10th TRIKO Valley ASHE is seeking new members.
