ASHE PIN Report - January 2014

As we start 2014, the federal highway cliff looms even closer. MAP-21, the Moving Ahead for Progress in the 21st Century Act (P.L. 112-141), was signed into law by President Obama on July 6, 2012, and expires on September 30, 2014. However, the \$105 billion funding for MAP-21 is set to run out before the bill expires. The House Transportation and Infrastructure Committee will hold its first hearing of 2014 on the renewal of MAP-21. To address the impending bankruptcy of the Highway Trust Fund, the ASHE National Legislative committee is assembling a PowerPoint to be distributed to all ASHE sections. The first section of the PowerPoint explains the Highway Trust Fund to the local public as it spirals towards bankruptcy, and the implications of the inaction of Congress to secure a funding source for the nation's infrastructure. The second section of the PowerPoint will include local projects that will benefit from federal funding and what this federal funding will mean to the average driver: reduced congestion, improved travel time, improved safety, etc. We urge all ASHE members to be thinking of such projects and help us define these local PowerPoint slides for the TRIKO Valley section. Once each ASHE section PowerPoint is ready, we ask all ASHE members to embrace the message, and share the PowerPoint with other organizations they belong to, and write letters to





the editor. It is important for everyone to participate in this grassroots effort.

In addition to the federal funding, funding for the Ohio Public Works Commission (OPWC) will be on the ballot for another 10-year renewal on May 6, 2014. The renewal of the program will include \$1.875 billion in financing for this program, which accounts for an increase in annual funding from \$150 million to \$175 million in the first five years and \$200 million in the last five years. The OPWC provides financing for local public infrastructure improvements through both the State Capital Improvement Program (SCIP) and the Local Transportation Improvement Program (LTIP). SCIP is a grant/loan program for roads, bridges, water supply, wastewater treatment, storm water collection, and solid waste disposal. LTIP is a grant program for roads and bridges only. As stated by the a number of the County Engineers of southwest Ohio, OPWC is the preferred funding program by local agencies for roads and bridges because of its ease of use. Voters last approved a \$1.35 billion program in 2005 with 54 percent of the vote. At the time, it was part of a broader \$2 billion bond issue that also included a new Third Frontier fund, investing in high-tech research and innovation. Again, it is important for ASHE members to talk with your coworkers, friends, and family about the importance of the passage of this issue, as it is the backbone of funding for so many local agencies.

Member Project Feature

The I-275/SR 28 Interchange Improvement Project

An intersection improvement project to enhance safety and improve operations on SR 28 at the Interstate 275 interchange in the city of Milford is nearly complete.

Modifications to the Interstate 275/SR 28 interchange were proposed as countermeasures recommended in a study conducted for the SR 28 corridor in response to safety and congestion issues.

At this interchange, 191 crashes occurred from 2006 through 2008, with crash numbers increasing from 53 in 2006 to 68 in 2007 and 70 in 2008; 71 percent of the crashes involved rear-end collisions. The most prominent trend identified involved 51 crashes directly associated with the left turn movement from westbound SR 28 to southbound I-275.

To offset the number of crashes associated with the left turn movement, the project constructed a loop ramp to permit westbound SR 28 to enter

southbound I-275 in a right turn movement. Work included construction of a right turn lane on westbound SR 28 to the new southbound loop ramp.



Work also included restriping SR 28 from McClelland Road east to Milford's Business 28 to convert the existing westbound left-turn lane to southbound I-275 into a third eastbound through lane and to extend the three through lanes beyond the northbound I-275 ramps to the next intersection with Milford's Business 28. In addition, the existing southbound I-275 off-ramp was realigned to accommodate and run parallel with the new southbound loop ramp. The signals at McClelland and the SR 28 southbound ramps were combined to operate under one controller, as well.

The John R. Jurgensen Company was awarded the project April 2012 on its bid of \$7,173,208.
