ASHE PIN Report - November 2015

As we approach the holiday season, our Christmas list includes a six-year, fully funded, transportation bill. Our last attempt at this wish was MAP-21, a bill that basically drained the surplus funds in the Highway Trust Fund. Now our federal highway bill is living day to day, with multiple infusions of life from the general fund to keep it afloat. The TEA Party mandates that Congressional Leaders sign a pledge of not passing any new taxes has hampered any support to raise the gas tax to coincide with a new transportation bill. So one again, President Obama has signed a two week extension on the current version of the Highway Bill. The highway bill that was approved by the House calls for spending up to \$261 billion on highways and \$55 billion on transit over six years. The legislation authorizes highway funding for six years, but only includes enough money to pay for the first three years. The Senate passed their version in July that would reauthorize highway programs for six years and provide \$47.6 billion of funding from the general fund to cover the Highway Trust Fund shortfall for the first three years. With the bill now going to conference, there is hope of passage of a transportation bill. However, the length that the funding will cover is still up for debate. Hopefully we will get our Christmas wish this year!

Great Lakes Region Outstanding Highway Project Award

At the ASHE luncheon at OTEC, Caroline Duffy (JMT Consultants Inc.) and Tom Flemming (Ford Development) accepted the Great Lakes Region Outstanding Highway Project Award (Under \$5 Million Construction Cost Division) for the Wooster Pike Revitalization Project, Phase 2 on behalf of JMT, Ford, and Prus Construction.



General Membership Meeting Minutes

September 22 - Montgomery Inn

President Beck called the meeting to order with the Pledge of Allegiance at 11:43 AM and recognized one guest.

Secretary Emerick noted that the minutes of the May meeting were published in the March newsletter and are on the table outside. A motion was raised by Ted Hubbard to accept the minutes which was seconded by Caroline Duffy and was accepted.

Eric Kistner presented the Treasurer's report, noting an operating capital of \$24,382.51. Expenses totaled \$11,199.75 and income totaled \$11,028.00. There are currently 185 members including 4 student members.

Caroline Duffy presented the PIN report, indicating that the authorization of the Highway Bill has not seen much progress. On July 31, the House passed the 30th extension, for five months and \$8 billion, with a promise that by December 18th, there will be a new highway bill. This is the time requested to finalize a major overhaul of the international business tax code, repatriation that has been the bipartisan support as the funding mechanism of the Highway Trust Fund. Over the summer, the Senate passed a version of the transportation bill, the DRIVE ACT (Developing a Reliable and Innovative Vision for the Economy Act), that promotes a six-year bill for the fiscal years of 2016 to 2021. This legislation has two components of Authorization and Programs and Acceleration of Project Delivery. The funding for the DRIVE act has not been determined. Since the funding of the Highway Trust Fund is still in limbo, it is important for our ASHE membership to continue to educate the public and to make known our desire for the passage of a long-term highway bill to our congressional representation. A PowerPoint with information on the Highway Trust Fund is on the ASHE national website. In addition, the ASHE funding stickers are available at the ASHE Store.

Stan Harris presented the Regional Report noting that we now have 806 members in the region. Tom Bolte is currently a national director whose term expires in May. The Great Lakes region nominating committee will make recommendations for his replacement. The region will be restarting the Circle City Section in the Indianapolis area. Applications will be due in April for the exposure funds from the sections and region. We sent the Schramm Awards winners on to National for announcement at OTEC this year. He reminded us to attend the national conference in Pittsburgh this year. We want to have great representation. Contact Stan Harris if you would like to advertise in the newsletter.

David Orr noted that the golf outing will be at the Vineyard again this year and asked members to see him if you would like to be a part of the committee.

Aaron Muck announced that he made a presentation at UC about our student chapter and is looking for opportunities to present at Cincinnati State and NKU. We would like to build the number of student members.

General Membership Meeting Minutes

Steve Shadix reported for Steve Mary that a tour of the Jeremiah Morrow Bridge will be offered by Dan Mendel. This walking tour will be limited to the first fifteen persons and you must bring personal protective equipment.

Vanessa Fritsch reported that the next event will be the holiday party. Please let her know if you have venue ideas.

Under new business, Eric Beck announced that we still have 15 members that have not renewed. Members must renew by October 1st to avoid initiation fees.

President Beck introduced Andy Barber from the KyTC who presented an update on the Ohio River Bridges project after which Eric adjourned the meeting.

Jeremiah Morrow Bridge Presentation and Walking Tour

On October 19th, 20 ASHE members gathered at the Jeremiah Morrow bridge construction site for a presentation and walking tour hosted by Dan Mendal. Dan is the Project Engineer for ODOT and has had the privilege to lead the construction of Ohio's tallest bridge. The Jeremiah Morrow bridge(s) is a cast-in-place, post tensioned, segmental concrete box, built using the balanced cantilever construction method. The bridges span 2252 feet across the valley and are 239 feet above the State and National Scenic Little Miami River. The deck is 55 feet wide which will accommodate three lanes of traffic in each direction in the future. The bridge is founded on 8 foot drilled shafts and HP 14x89 steel piling. Five piers support the superstructure and are made up of three distinct sections. The pier bases vary in height having three foot thick walls and are hollow so that they can be easily inspected. The pier diaphragms are constructed on top of the pier bases and are 8 foot thick solid concrete. The diaphragms are the transition point from the pier base to the twin walls which extend to the pier table. The pier table is the first box section cast. The remaining deck sections are then cast using the balanced cantilever construction method alternating from each side of the pier table.

After the presentation we walked to the south end of the bridges. Once on the project site one truly gets an appreciation for the size and scope of this bridge project. The group walked inside the first bridge constructed that currently carries northbound I-71 traffic to observe the finished bridge. The group then had the opportunity to cross the walkway to the bridge under construction to observe up close the post-tensioning, re-steel placement and forming necessary to cast the next segment. All enjoyed this exciting construction tour.

GENERAL CRITERIA

- 1 Projects entered in the competition must be located within the geographic area of the ASHE - TŘIKO Valley Section.
- Construction of the project must have been substantially completed and ready for use 2. between January and December of the competitions current year.
- 3. Entries must be sponsored by a member of the ASHE - TRIKO Valley Section.
- 4. Each submitted entry must be accompanied by the materials outlined in the Submission Requirements.
- ASHE TRIKO Valley Section will not be responsible for any damage or loss to entrant's 5. submission materials.
- 6. The ASHE - TRIKO Valley Section Board of Directors reserves the right to determine the eligibility of all entries.

SUBMISSION REQUIREMENTS

Entries must include:

- 1. The original and two (2) copies of the Official Entry Form.
- 2. The signature of the sponsoring member on the entry form will be considered verification that the project is substantially completed and ready for use between January and December of the competitions current year.
- Two (2) copies of a project description, not to exceed two (2) pages (8.5" x 11" with 1" side 3. margins, minimum 11 point font) excluding any pages containing photos, graphs, charts, etc., within the two (2) page limit. (Some suggestions of content in the submission are original or innovative application of new or existing design, and/or construction techniques or materials, technical value to the engineering or construction profession, social, economic, and environmental value to the region, complexity, and rating of the expectations of the owner or the regional needs.)

JUDGING OF ENTRIES


- All entries will be judged by the nine (9) members of the ASHE TRIKO Valley Section Board of Directors.


