GENERAL MEMBERSHIP MEETING MINUTES

Tuesday, January 26, 2016 - Montgomery Inn

President Beck called the meeting to order with the Pledge of Allegiance at 11:48 AM and recognized four guests.

Secretary Emerick noted that the minutes of the September meeting were published in the section newsletter and no notes were taken for the holiday meeting held at the Yard House. Triko Valley is in the process of posting our documents on the ASHE Cloud. A motion was raised by John Davidson to accept the minutes which was seconded by Steve Mary and was accepted.

Eric Kistner presented the Treasurer's report, noting an operating capital of \$23,428.45. Expenses totaled \$7,190.15 and income totaled \$6,260.00. There are currently 177 members including 3 student members.

Caroline Duffy presented the PIN report, indicating that the Fixing America's Surface Transportation Act (FAST) was passed after 33 extensions, providing \$305 billion in funding, increasing by 11% over the next five years. The source of this long term funding is one-time gains, such as cutting dividend payments from the Federal Reserve to banks with more than \$10 billion in assets, reallocating unspent earmark monies and continued infusions of \$70 billion from the general revenue fund. While the 93% apportions of the Highway Trust Fund back to the states and the basic program structure remain the same, some features have changed including a reduction in funding for the Transportation Infrastructure Finance and Innovation Act (TIFIA), streamlined project delivery through an improved review and permitting process and proportionate funding increases for both the highway and transit portions of multimodal programs. Caroline encouraged us to contact Congressional leadership to request that they pass the appropriations of the FAST Act funding in a timely manner.

The Regional Board conference call scheduled last week was cancelled. Stan Harris attended the National Board meeting on January 16th. The National Board is working hard on many fronts including starting new sections and strengthening existing sections, developing partnerships with other organizations that support the transportation industry, providing resources to support student chapters, etc. The Board does all of this with almost 100% volunteer labor. President Beck asked members to log into the membership database on the National web site of ashe.pro and update personal information.

Eric Beck noted that the golf outing will be at the Vineyard again this year and asked members to see David Orr if you would like to be a part of the committee.

Brian Rhodes announced that membership applications are available at the table outside.

Aaron Muck noted that he continues to build the student section and is using the successful Delaware student section as a model. He announced that we are looking for volunteers to be involved in the Ohio Valley Student Conference. This is a student competition including a bridge competition and concrete canoe races which is held in Lawrenceburg, Indiana.

Steve Mary announced that ASHE will conduct a technical tour of the new ark in Williamstown, Kentucky on February 2nd. This is the largest timber structure in the world. We will meet at 9:30 am on site and all participants must bring their own PPE as this is an active construction site.

Vanessa Nghiem noted that the holiday meeting held in conjunction with the WTS group was very successful, with a large turnout. We will probably not do a March Madness happy hour event this year, so our next event will be the Reds game on May 19th. Please let Vanessa know if you have venue ideas.

President Beck announced the Schramm Project presentations as follows:

Vanessa Nghiem raised a motion to adjourn the meeting which was seconded by Steve Mary and passed. President Beck adjourned the meeting at 1:28 pm.

ASHE PIN Report - March 2016

The ASHE National Legislative Committee has revised the Federal Program Position statement. This statement aims to "support and promote critical transportation policies and funding issues through legislative networks and by educating the general public on the value of these policies and issues." The ASHE Federal Program Position contains the following seven goals:

- 1. A federal presence in transportation to ensure safe and efficient movement of people and goods throughout the country.
- 2. All revenues generated from transportation user fees should be reserved for use for transportation purposes.
- 3. All revenue sources to fund the Highway Trust Fund need to be indexed in inflation to maintain more buying power over time.
- 4. Actions should be taken to broaden the revenue base for transportation funding to allow for a continuing, sustainable, and predictable Federal-aid program.
- 5. Congress needs to ensure dependable funding to the transportation industry to entirely fund the FAST Act and provide long term funding beyond.
- 6. Federal environmental, air quality, and planning regulations should be streamlined and made concurrent/consistent to the maximum extent possible.
- 7. It is believed that the states and their local government partners, through the federally mandated cooperative planning processes, are in the best position to assign project priorities and make decisions on how to allocate scarce revenues to various project categories within each state.

An update the FAST Act: The Federal Highway Administration issued formal implementing guidance February 29th that allows state departments of transportation to begin drawing on \$1.15 billion for this year that was apportioned to them for freight-related projects under the new FAST Act. That funding stream is the first infusion of money for the new National Highway Freight Program. The five-year highway authorization law also provides \$1.1 billion for this program in fiscal 2017 that begins October 1st; then it will grow in the final three years of the FAST Act to \$1.2 billion, \$1.35 billion, and \$1.5 billion. Another benefit to state DOTs is that the money is apportioned to them under the same formula as their regular highway program allocations from the Highway Trust Fund. Eligible projects shall contribute to the efficient movement of freight and be identified in a freight investment plan. Some examples of how state DOTs can spend the funds are for road projects that separate passenger vehicles from commercial trucks, or for the flyover bridges that eliminate rail crossings by lifting road traffic over train tracks. Others could be truck-only highway lanes, truck parking facilities, electronic screening, and border security technologies. The project list includes more traditional road and bridge capacity projects as well, if they address highway freight bottlenecks and improve truck movement. States can also use up to 10 percent of the funds to improve cargo flow in and out of freight intermodal, marine port, or freight rail facilities.

In Ohio, the Transportation Task Force required by the ODOT budget is having hearings. This committee is chaired by Representative Cheryl Grossman (R- Grove City). At the first hearing, Delaware City Manager Tom Homan spoke in favor of the permissive license fee increase. The County Engineers Association of Ohio is trying to get a bill drafted for the increase. This bill has the support of both the rural and urban counties that need an increase in funding for their failing infrastructure.

The Kentucky General Session is currently in session. On February 9, 2016, the Kentucky Senate passed a bill clarifying how motorists interact with bicyclists by a 33-4 vote. Key provisions in the legislation, known as Senate Bill 80, would require bicycles to keep to the right and would require motorists to stay at least three feet away from bicycles when passing. Many signers of the bill recognize that there is an increase in bicycling for health reasons, as well as an alternative method of transportation to and from work and shopping, and for tourism. SB 80 now goes to the Kentucky House of Representatives for further consideration.

ASHE Triko Valley 2016 Scholarship

The ASHE-TRIKO VALLEY section will be making scholarship awards to college enrolled students. It is anticipated that an award totaling Two Thousand Five hundred dollars will be awarded annually. The size of this amount requires that a formal procedure be in place and rigorously adhered to. It is recommended that the procedure be developed and amended as necessary by the Scholarship Committee.

There are essentially five components of the scholarship process to insure a successful scholarship program. They are as follows:

Advertisement

- In order to ensure maximum participation it is necessary to disseminate facts relative to the existence and details of the scholarship program.
- We will announce the scholarship and have the application packet be posted on the ASHE website.

Eligibility and Application

The following eligibility criteria is as follows:

- College student who is expecting to graduate from a transportation or construction related program within the next two school years.
- Students are attending the following schools: University of Dayton, University of Cincinnati, Ohio College of Applied Science, Cincinnati State and Technical College, and Northern Kentucky University or students are full time residents within the ASHE TRIKO Valley geographic areas of southwest Ohio, northern Kentucky or southeast Indiana.
- It is recommended that applications be developed that adequately evaluate the applicant's suitability for the award. It would be worthwhile to research other award program applications to obtain ideas. It is recommended that the Scholarship Committee develops the application form and modifies it, as necessary, over time.
- Applications will be made available during the 2015-2016 school year to allow the applicant time to prepare the application.
- Applications should be received by a date that will allow for review period of one month, with award decision and award notification no later than June 30, 2016. If decision is made prior to Golf Outing, presentation to winner(s) will be at annual Golf Outing in June.

Review

- The scholarship committee should be expanded to include at least 3, but no greater than 5 committee members.
- The committee will review applications and discuss individual analysis collectively.
- The committee will determine the winner(s) and the TRIKO Valley BOD will award scholarships.

Award

• The award would be one (1) \$1500.00 Scholarship and one (1) \$1000 Scholarship.

Distribution

• The award distribution would be made directly by check to awardees.

There is a change in eligibility this year. In previous years, only students entering their last year of school were eligible. Starting this year, students entering either of their last TWO years of a construction or transportation related industry program are eligible.

Ark Encounter

Noah's Ark is being constructed to biblical proportions in Williamstown Kentucky. The Ark will be the largest wooden structure in the world at 540 feet long and four stories high. Massive timber framing and many large glulams are being used in this project.

On February 2nd, six ASHE members toured the site and all were impressed with the overall size of the Ark and the thousands of different connections





needed for the many different sizes of lumber incorporated into the framing.

Tours open to the public will start on the first level and proceed up long wooden ramps to the next level. As you walk the ramps, you will see many displays containing animals as well, as Noah and his family stored provisions. Some live animals will be in wooden cages while the public visits the ark. This wooden structure meets

all modern building codes, as they anticipate 10,000 people being in the ark when it opens to the public on July 7, 2016. Additional phases will include a restaurant on the fourth level and other attractions, such as the Tower of Babel and zip-lines, which will be added to the project over time.




