GENERAL MEMBERSHIP MEETING MINUTES

Tuesday, March 15, 2016 - Montgomery Inn

President Beck called the meeting to order with the Pledge of Allegiance at 11:48 AM, recognized four guests and announced that save the date cards are available for the upcoming golf outing.

Secretary Emerick indicated that the minutes of the January meeting were published in the Section newsletter and are on the back table. A motion was raised by Steve Mary to accept the minutes which was seconded by Vanessa Nghiem and passed.

Eric Kistner presented the Treasurer's report, noting an operating capital of \$23,428.45. Expenses totaled \$2,518.98 and income totaled \$2,000.00. There are currently 184 members including 3 student members.

President Beck announced that the PIN report was published in the newsletter.

Stan Harris presented the regional report, noting that he attended the January National Board Meeting and that the National Treasurer is in attendance today. Stan announced that we would like additional articles lined up for the Scanner newsletter.

David Orr announced that the annual golf outing will be held on June 24th for same cost as last year of \$95 per person. We are offering an early bird package of discounts and are looking for a beverage sponsor this year at a cost of \$600. Members were asked to contact David if they have any questions. President Beck asked us to register early for the golf outing.

Eric Beck covered the membership report on behalf of Brian Rhodes. He announced that members who either refer a new member before the next meeting or who bring a guest to the May 17th General Membership Meeting will be entered into a drawing to win one of four \$25 Yard House gift cards.

Aaron Muck reminded us of opportunities to volunteer at the Ohio Valley Student Conference (OVSC) coming up from March 31st thru April 1st in Lawrenceburg, Indiana.

Steve Mary provided an update that Tommy Arnold from ODOT will report on the MLK project at the May meeting. Land-Between-the-Lakes will be the topic for the September general membership meeting. The ARK Encounter tour was very successful. We are looking for other tours, including the Portsmouth bypass.

Nathan Moore reported that the scholarship application is due by May 13th and has been updated on the website. One change is that students in their last two years of school are eligible for the scholarships of \$1000 and \$1500. Please encourage students to apply. Nathan also announced that a Seaton High School student is trying to arrange an ongoing shadowing program as a senior project. Let Nathan know if you are interested in participating.

Vanessa Nghiem reported that the Reds game outing will be on May 19th against the Indians and will include drink tickets and a buffet in the Reds landing. This event is in partnership with the OCA. We are open to partnerships for other events.

The annual Schramm Awards were presented to:

Hamilton County Park District's Little Miami Bike Trail-Phase 1(under \$5 million) and ODOT's I-275 and SR32 Interchange Modification (over \$5 million)

Next, Eric Beck introduced a panel of representatives from MSD, the City of Cincinnati, Clermont County, Butler County, ODOT, Hamilton County, the Kentucky Transportation Cabinet, SD1 and Montgomery County who presented information on their respective Capital Improvement Programs (CIP) and entertained questions from the audience.

After the CIP roundtable, Dennis Brunton raised a motion to adjourn the meeting which was seconded by Vanessa Nghiem and carried. President Beck adjourned the meeting at 1:30 pm.

ASHE PIN Report - March 2016

With the FAST Act passage in December of 2015, funding has been secured for the next four years. While the FAST Act provided a stop gap during this time period, it is apparent that a long term funding solution still eludes the country. ASCE's Failure to Act study assesses how the nation's failure to improve its infrastructure systems affects economic performance. Even with the FAST Act funding, during the next decade it is estimated an additional \$1 trillion is needed across the transportation network, including roads, bridges, and rail. The report relates this to increased production costs, increased cost of travel, and decreased consumer spending. It will cost each U.S. family \$3,400 a year over the next decade in the form of higher costs for transportation, electricity, and water. In addition, this gap could strip 2.5 million jobs and \$4 trillion of gross domestic product from the economy. It is estimated that by 2025, only 53.9% of the surface transportation needs will be funded.

Congress is attempting to address the lack of permanent funding for the Highway Trust Fund. Since the House Ways & Means Committee is currently developing a blueprint for updating and reforming the tax code, Representatives Sam Graves (R-MO) and Eleanor Holmes Norton (D-DC) are calling for a permanent solution to the Highway Trust Fund in any broader tax reform proposal. This is the solution implemented as part of the tax reform during President Clinton's second term in office that resulted in the last gas tax increase in 1993.

We encourage you to contact your representative (go to http://www.house.gov/representatives/find/ and enter your zip code) and let them know just how important a sustainable funding stream is for the economy of the country. Let your Congressional Representative know that this is a concern, and perhaps a long term funding stream for the Highway Trust Fund can finally be secured.

ASHE Triko Valley 2016 Scholarship

The ASHE-TRIKO VALLEY section will be making scholarship awards to college enrolled students. It is anticipated that an award totaling \$2,500 will be awarded annually. The size of this amount requires that a formal procedure be in place and rigorously adhered to. It is recommended that the procedure be developed and amended as necessary by the Scholarship Committee.

There are essentially five components of the scholarship process to insure a successful scholarship program. They are as follows:

Advertisement

- In order to ensure maximum participation it is necessary to disseminate facts relative to the existence and details of the scholarship program.
- We will announce the scholarship and have the application packet be posted on the ASHE website.

Eligibility and Application

The following eligibility criteria is as follows:

- College student who is expecting to graduate from a transportation or construction related program within the next two school years.
- Students are attending the following schools: University of Dayton, University of Cincinnati, Ohio College of Applied Science, Cincinnati State and Technical College, and Northern Kentucky University or students are full time residents within the ASHE TRIKO Valley geographic areas of southwest Ohio, northern Kentucky or southeast Indiana.
- It is recommended that applications be developed that adequately evaluate the applicant's suitability for the award. It would be worthwhile to research other award program applications to obtain ideas. It is recommended that the Scholarship Committee develops the application form and modifies it, as necessary, over time.
- Applications will be made available during the 2015-2016 school year to allow the applicant time to prepare the application.
- Applications should be received by a date that will allow for review period of one month, with award decision and award notification no later than June 30, 2016. If decision is made prior to Golf Outing, presentation to winner(s) will be at annual Golf Outing in June.

Review

- The scholarship committee should be expanded to include at least 3, but no greater than 5 committee members.
- The committee will review applications and discuss individual analysis collectively.
- The committee will determine the winner(s) and the TRIKO Valley BOD will award scholarships.

Award

The award would be one (1) \$1500.00 Scholarship and one (1) \$1000 Scholarship.

Distribution

The award distribution would be made directly by check to awardees.

There is a change in eligibility this year. In previous years, only students entering their last year of school were eligible. Starting this year, students entering either of their last TWO years of a construction or transportation related industry program are eligible.







