It appears the Ohio House will be voting to cut ODOT's requested 18 cent a gallon gas tax hike indexed to inflation to 10.5 cents spread over three years with no indexing. This is not going to be adequate to meet the needs of local agencies and make Ohio a better place to do business and improve our quality of life. Hopefully, the House and Senate can agree on a larger increase even if spread over more years. Make your voice heard, this impacts all of us professionally and personally!

# **ASHE PIN Report - March 2019**

With a new governor in Ohio and a new director at ODOT, progress is being made on the additional funding needed for Ohio's transportation budget. Governor DeWine has introduced in transportation budget proposal, which included a gas tax increase of 18 cents indexed to inflation in an effort to keep up with our neighboring states. Ohio, with the nation's 4th largest interstate system, the 2nd largest inventory of bridge, and the 6th highest number of vehicle miles traveled in the nation, is falling behind.

The House approved HB 62 on March 7, 2019, by a vote of 71-27 that included these major changes to the Governor's proposal:

- Reduced gas tax increase from 18 cents to 10.7 cents per gallon beginning October 1st to be phased in over 2 years (7 cents and 3.7 cents)
- Increase tax on diesel fuel by 20 cents to 48 cents per gallon beginning October 1st to be phased in over 3 years (10 cents, 6 cents, 4 cents)
- There is no indexing but the creation of a study committee to report ODOT's needs by October
- Increased funding for public transit to \$100 million per year in flex funding
- \$200 registration fee on electric vehicles, \$100 on hybrid vehicles

HB 62 does not provide new money for additional safety and or money for the major new program.

The Senate version is up for vote on March 20. Please contact you State Senator and let them know you support the Governor's proposal.

The Federal Highway Bill is set to expire at the end of 2020. Current word is that an extension will be reviewed with a study to find a fix. Hopefully this Congress and President will be able to break this log jam in inaction to improve our transportation system on a national level. This inaction is another reason why passage of the Ohio gas tax to 18 cents is so important. Please do your part.

# 2019 ASHE TRIKO Valley Section Lloyd Wallace Memorial Golf Outing

#### January 22, 2019 - Montgomery Inn




