## From Our President...



As we wrap up the 30th Anniversary year of the TRIKO Valley Section, I was thinking back to all the changes we have seen in the last year. We have honored nine ASHE members that have been active for over 25 years with an ASHE Life Membership. Thank for your service to our industry. At this time last year, we were discussing the need for a revenue increase. Last year, ODOT's program was continuing to shrink, at least on the design side. Now we have a new Transportation Bill that will add \$850 million per year to ODOT's budget, about \$5 million for the City of Cincinnati, and \$1.5 million for all 88 Counties in Ohio. Thanks to Caroline for peppering the State House with emails - your campaign to fill their mail boxes worked! Now if the Feds can increase the Federal gas "user fee" another

10 cents per gallon indexed to inflation and follow Ohio's lead on increased registration fees for electric vehicles, we will have a 10 to 12-year solution to transportation funding. I discussed this topic with FHWA at the ACEC/ODOT Partnering Conference.

Another exciting change has been the growth of the Section as we continue to add members. The increase in student members is great, and its free! Keep encouraging your staff to join ASHE and be part of a great professional association. The TRIKO Valley Section has also increased our Scholarship fund in conjunction with the John R Jurgensen Company with the Jim Jurgensen Memorial Scholarship, starting in 2019. Let your Co-Ops and civil engineering students know about this great opportunity.

Our next General Membership Meeting at the Original Montgomery Inn will be on May 21st where Andy Pilgrim from the NCM Motorsports Park (National Corvette Museum) and the Traffic Safety Education Foundation will be our featured speaker. Andy will be discussing his racing career along with transportation safety.

The ASHE National Conference in Nashville was held from May 8-12th. Attendance was over 500 people. If you didn't make it, I encourage you to go to Raleigh, NC for the 2020 conference.

## **ASHE PIN Report - May 2019**

First, the ASHE PIN wishes to thank all that contacted their representatives in Ohio about the need for a state gas tax. In the end, the state did pass the gas tax increase of 10.5 cents for regular fuel and 19-cent for diesel fuel into law. This increase will generate \$865 million in new funding for infrastructure improvements. In addition, the transportation budget bill also added registration fees for electric and hybrid vehicles at \$200 and \$100 respectively along with a permissive \$5 license tag fee allowed at the county level raising the maximum fee levied from \$25 to \$30. Unfortunately, indexing the gas tax was not included in the final bill. One major change is the local governments will receive more from the gas tax than previously. The average city and village will receive an increase of locally administered fund of 62.5%. County engineers will see a 62.8% increase annually and townships will increase on average increase of 67 %. ODOT will see an increase of 24% in their revenues. Again, thanks to all that performed outreach with the state representatives and let them know how important this gas tax increase is to improving transportation in Ohio.

Second, the national transportation bill is again facing a fiscal cliff, with expiration of the current bill in October 2020. With the release of the Mueller Report, a national infrastructure bill is now being discussed. At the end of April, House Speaker Nancy Pelosi and Senate Minority Leader Chuck Schumer met with President Trump to focus on advancing "bipartisan action on a bold infrastructure bill to create jobs and grow our economy in a green and modern way." The Speaker and Minority Leader presented the President with an infrastructure package of up to \$2 trillion over 10 years. Trump has asked Congress for \$200 billion over the same period in his fiscal 2020 budget request, which the administration had asserted could attract \$1 trillion in state and private sector spending. The outcome of the meeting was positive with a follow-up meeting scheduled the week of May 19. In this meeting, the President will propose a way to pay for the infrastructure package. It is hoped that the President will modify his transportation funding proposal presented in February 2017 that relied heavily on leveraging private financing and require states to put up a significant portion of the money, as this was rejected by lawmakers of both parties. Industry experts are pushing for a gas tax increase between 20 cents over four years to over 25 cents per gallon over five years.

Finding a compromise to the federal transportation bill is critical to the infrastructure programs of the states as many projects heavily rely of the federal monies. The ASHE PIN urges you to contact your Congressional Representative to let them know that you support a federal gas tax! ### March 19, 2019 - Montgomery Inn

President Steve Mary called the meeting to order with the Pledge of Allegiance at 11:32 AM and led the group in the Pledge of Allegiance. Due to this being a joint meeting with OCA and a large attendance, individual guests were not introduced.

President Mary asked for approval of the January meeting minutes. After a motion by Eric Beck and second by Brian Rhodes, the motion passed.

Eric Kistner presented the Treasurer's report, noting an operating capital of \$24,126.60. Major expenses included registration web site fees and scholarships while major income item was registrations for March meeting. Stan Harris made a motion to approve and Caroline Duffy seconded. The motion was approved.

Stan Harris said there was not a Newsletter/Scanner report but noted the upcoming National Conference in Nashville at the Gaylord Hotel May 8-11 and encouraged everyone to attend.

Caroline Duffy gave the PIN report. Governor DeWine proposed an 18 cent per gallon increase in the gas tax but the House has reduced it significantly in its version. The bill will be voted on by the Senate this week and ASHE members should contact their state Senators and support the Governor's proposal. The Federal Highway Bill is set to expire at the end of 2020. Current word is that an extension will be reviewed with a study to find a fix. See the PIN article in the newsletter for full details. Paul Gruner will be serving on an ARBTA committee to develop recommendations for the next transportation bill. If you have input you can contact Paul directly or Caroline Duffy.

Melanie Kitchen and Mark Nelson from OCA made several announcements and presented four scholarships to area students.


