# **General Membership Meeting Minutes**

#### May 21, 2019

President Steve Mary called the meeting to order with the Pledge of Allegiance at 11:40 AM. Two student guests were recognized, Lisa and Jenny. Steve announced that the section won the Robert E Yeager award for the most inclusive section at the recent National Conference.

President Mary asked for approval of the March meeting minutes. After a motion by Eric Beck and second by Stan Harris, the motion passed. Three regional chair positions are open. No additional items were presented by the secretary.

Eric Kistner was not present so Steve Mary reviewed the monthly financial statement noting a balance of \$31,000.

Stan Harris said that the award-winning newsletter is on the website. We will be looking for articles for the Newsletter/Scanner.

Tom Nicholson noted that we recently had a highway cleanup day and will plan on another event in fall.

Caroline Duffy gave the ASHE PIN report thanking everyone that contacted their representatives in Ohio about the need for a state gas tax. An increase of 10.5 cents for regular fuel and 19 cents for diesel was passed into law, generating \$865 million in new funding for infrastructure improvements. Registration fees for electric and hybrid vehicles and the county \$5 license tag fee were also included in the transportation budget bill. The national transportation bill is again facing a fiscal cliff, with expiration of the current bill in October 2020. House Speaker Nancy Pelosi and Senate Minority Leader Chuck Schumer presented President Trump with an infrastructure package of up to \$2 trillion over 10 years which he asserted could attract \$1 trillion in state and private sector spending. Industry experts are pushing for a gas tax increase between 20 cents per gallon over four years to over 25 cents over five years. ASHE PIN urges you to contact your Congressional Representative to let them know that you support a federal gas tax.

A national student chapter survey was sent out. Arron Muck reviewed the results, noting that the chapters in our region are in the growing phase. ASCE has a very large presence locally and we will look for alignments and opportunities to establish local charters.

Katie Dillenburger announced that the golf outing was a success with 72 golfers participating. This event is important as it funds our scholarships.

Steve Mary noted that the scholarship application is on the website.

President Mary announced that they are looking to set up a tour of the FC Cincinnati stadium. There are no updates on the social committee. In May, there was an opportunity to attend a Reds game with the OCA.

Steve asked for nominations for a new first year director at which time Todd Gadbury was nominated by Ted Hubbard. Steve asked members to contact the board with further nominations.

President Mary introduced Andy Pilgrim from MCM Motorsports who gave an informative presentation on distracted driving and traffic safety.

The meeting was adjourned at 1:00 pm after a motion to do so was raised by Ted Hubbard.

# **ASHE PIN Report - September 2019**

The hope that the Congress and the President could work together on a much-needed transportation bill was dashed only two days after the last ASHE TRIKO Valley general membership meeting, when President Trump announced in a five minute meeting with the Democrat leaders that he would not talk with them if they were still talking about impeachment proceedings.

However, the Congressional committees still move forward. Over the summer, the Senate Environment and Public Works Committee crafted a five-year highway bill, the \$259 billion the American's Transportation Infrastructure Act of 2019, that was approved in late August. The bulk of the package – \$259 billion per year – is for maintaining and repairing America's roads and bridges. Another \$10 billion is earmarked for projects to improve air quality and resilience.

"This bipartisan legislation includes the first-ever climate change items in a highway bill and would invest \$10 billion in policies and innovative projects aimed at reducing emissions and enhancing resilience," ranking member and co-sponsor Thomas Carper (D-Delaware) said.

The bill also earmarks \$1 billion for competitive grants to support the development of fueling infrastructure for electric, natural gas, and hydrogen-powered vehicles. Committee members said their hope is that increased public funding will also encourage private investment and new technology. It includes a provision, called the Bridge Investment Act, to create a competitive grant program aimed at easing the backlog in work needed on functionally obsolete bridges like the Brent Spence Bridge, and structurally deficient ones like the Western Hills Viaduct. The bill also streamlines project delivery and federal approvals.

The House also passed a transportation bill this summer that would provide \$86.6 billion per year for infrastructure, and an infrastructure grants program at DOT that would receive \$1 billion. However, the House Senators, such as Rep. Kay Granger of Texas criticized the bill.

"House Democrats have wasted opportunity after opportunity to pass meaningful, bipartisan appropriations bills," Granger said, adding, "Instead, they have written bills that irresponsibly increase spending and include partisan riders that Republicans simply cannot support," and emphasized it would not be signed into law.


