# ASHE-TRIKO Valley Section **General Membership Meeting Minutes**

### **TUESDAY, MAY 18, 2021 | VIRTUAL MEETING**

President Aaron Muck called the meeting to order at 11:30 AM, welcoming attendees, noting that we have a lot of ground to cover today and observing a few moments of silence to set the stage for the meeting. He presented a safety reminder of the five Smith System key safety rules including aim high. He also encouraged us to see the big picture and not get distracted. General announcements included that we are still sticking with virtual meetings until the fall. A highway cleanup and golf outing are planned in the near future. Aaron announced that we are seeking nominations for the first-year director for the ASHE TRIKO valley board. Please let a board member know and a virtual vote will follow. The new slate of officers will be installed in the fall meeting.

For the secretary's report, a motion was raised by Todd Gadbury to approve the January 19, 2021 General Membership Meeting notes which are posted in the newsletter. The motion was seconded by Bill Fair and passed with no opposition. Bill Fair raised a motion to approve the March 18, 2021 CIP meeting notes which was seconded by Dan Ficker. There were no comments, and all were in favor.

Treasurer Kistner reported that the current operating capital is \$16,574.76 and we currently have 179 members. Bill Fair raised a motion to accept the Treasurer's report which was seconded by Katie Dillenburger and carried unanimously.

Caroline Duffy presented the PIN report, noting that Governor DeWine signed HB74 (FY 2022-2023 transportation budget) into law on March 21st. The state TRAC process has also restarted. Kentucky HB 561 did not make it out of committee. The American Jobs Bill is in bipartisan negotiations which include revoking of tax cuts to pay for it. The bill includes \$621 billion for infrastructure. There is a goal of passing the American Jobs Bill on July 4th. Having an infrastructure bill is a good sign!

Todd Gadbury thanked everyone who submitted Schramm Project Award applications and announced the winners as follows:

Katie Dillenburger noted that the golf outing was announced in the newsletter and will be held on June 21st at Aston Oaks with an 11:00 am shotgun start. She encouraged us to register online. We are looking for a good turnout as this is our fundraiser for student scholarships.

Paul Durham was not present to provide a website update. President Muck invited members to check out the clean new website look.

There were no program updates from Steve Mary.

Steve Mary introduced Mike Ellerbrook and Jeff Heimann from Strand Associates, who presented on the Lick Run Valley Conveyance System. After the presentation, questions were fielded and the presenters were thanked.

William Fair raised a motion to adjourn the meeting which was seconded by Eric Beck and carried. The meeting was adjourned by President Muck at 1:05 pm.

## **ASHE PIN Report - September 2021**

Congress is close to passing the much-needed Transportation Bill. With the funding authority for the Highway Trust Fund teetering on bankruptcy as the September 30 deadline approaches, the transportation bill will replenish the Trust Fund, albeit from a deposit from the General Revenue Fund. The separation of the Transportation Bill from President Bidens \$3.5 trillion social infrastructure and tax plan has given traction to the Transportation Bill's passage while letting the \$3.5 trillion social infrastructure and tax plan continue in debate.

Speaker of the House Nancy Pelosi has issued a voting deadline of September 27 for the Highway Trust Bill. The legislation includes \$100 billion for roads and bridges, \$66 billion for freight and passenger rail operations, \$65 billion for broadband internet access, \$46 billion for severe weather-resilience climate change programs, \$39 billion for transit systems and \$25 billion for airports.

A pillar of President Joe Biden's "build back better" agenda, stakeholder groups, such as the U.S. Chamber of Commerce, had applauded Senate passage of the infrastructure bill earlier this month.


"Our elected leaders are on the precipice of a historic investment in our nation's crumbling infrastructure," said Chamber of Commerce president and CEO Suzanne Clark. "Turning this long-overdue promise into a reality will grow our economy and strengthen our competitiveness for decades to come. We applaud the Senate for doing its job on a bipartisan basis, thoughtfully debating and passing much-needed infrastructure legislation that will finally invest in America's roads, bridges and other critical infrastructure, create millions of jobs, and improve the quality of life for every American. Now it is time for the House to continue the bipartisan progress and send this bill to the president's desk."

While this historic measure is what our industry has been advocating for several years, several states are scrambling. Kentucky officials have said that if this funding transpires as planned, they will not have enough matching state funds to take all of the federal funds from the bill, in which case it would be allocated to other states. They are now meeting to see how to adjust their projects and funding to not turn away federal funding. Ohio, fortunate enough to have a recent gas tax, is set to accept this new funding from the bill. In addition, the earmarks that were added to the House version have been removed, but the thought is they will be added in the appropriations process.

What can ASHE do to help the passage of the new Highway Bill? Now is crucial to contact your House and Senate representative! Tell them that you support the passage of the bill! Please do your part and contact your Congressional leadership!
